## HOLD HARMLESS CLAUSE

In consideration of being permitted by The Rotary Club of Naperville (RCN) and The Rotary Club of Naperville Charities (RCNC) to participate in The Rotary Club of Naperville Holiday Parade of Lights (the "Parade"), I, being an authorized representative of the Organization/Entry identified above, ("my Organization") and with authority to bind the Organization and its participating individuals agree that my Organization, its participating individuals, and respective heirs, guardians, legal representatives and assigns will not make a claim against, sue, attach the property of, or otherwise prosecute any claim, suit or matter against RCN and RCNC, their officers, directors, members, agents, employees, sponsors or volunteers for any injury, death, or property damage occurring to me or members of my Organization as a result of or relating to the Parade, whether caused by the negligence of RCN, RCNC or otherwise.

If any claim for personal injury, death, or property damage is asserted against RCN or RCNC, or any of their officers, directors, members, agents, employees, sponsors, or volunteers as a direct or indirect result of my or my Organization's participation in the Parade, my Organization will indemnify and hold harmless RCN and RCNC, their officers, directors, members, agents, employees, sponsors or volunteers from all such claims, causes of action, or damages, including attorneys' fees, by whomever made and wherever presented. The Organization and its participating individuals agree that my Organization, and its participating individuals, agree that we are voluntarily participating in the Parade and assume all risks associated with that participation.

The foregoing is given willingly and based upon my Organization's, its participating individuals, and our own independent judgment and not on any representation made by RCN and RCNC.

My Organization and its participating individuals acknowledge and will comply with all applicable Parade rules, regulations or directives.
